CALIFORNIA VALUES ACT REPORTING FOR 2025

The California Values Act mandates law enforcement agencies collect, and report specified data regarding an agency's participation in events outlined below for every calendar year:

Government Code section 7284.6, subsection (c)(1) requires agencies participating in a "joint law enforcement task force", defined as at least one California law enforcement agency collaborating, engaging, or partnering with one federal law enforcement agency in investigating federal or state crimes, report: (1) the purpose of the task force; (2) the federal, state, and local agencies involved in the task force; (3) the total number of arrests made by the task force during the reporting period; and (4) the total number of arrests made by the task force for immigration enforcement purposes.

Government Code section 7284.6, subdivision (c)(2) requires agencies to report the number of transfers the agency made to immigration authorities, as permitted by Section 7284.6, subdivision (a)(4) and the offence that allowed for the transfer.
