-Self-reported place of birth is based on information provided by the individual during the current booking. Self-reported home address is based on the last known home address listed in the individual's booking history.

-Current booking primary charge is the first charge listed on the current booking (Arrest #1/Charge #1). This field does not reflect the disposition of the listed charge and/or subsequent charges, nor is it indicative of the highest-level charge.

-Facilities: San Diego Central Jail (SDCJ); George Bailey Detention Facility (GBDF); East Mesa Re-Entry Facility (EMRF); Vista Detention Facility (VDF); Las Colinas Detention and Re-Entry Facility (LCDRF); South Bay Detention Facility (SBDF); & Rock Mountain Detention Facility (RMDF)

-Qualifying conviction/charge is the qualifying offense that allowed for the transfer of custody to immigration authorities as permitted by SB54. This qualifying offense may originate from either a current convicted offense or a prior conviction.
